I was raised on a small farm near Yarbo, Saskatchewan. Walking 3/4 of a mile on good days, and riding behind a team on bad days, I attended St. Elizabeth country school. With desks circled around the huge stove to keep us warm, I decided that a teacher was what I wanted to be. I graduated from Esterhazy High, Teacher's College in Regina, and the University of Saskatoon. I taught grades 1 to 8 in the Crescent

country school, grades 1 to 5 in Dunleath 2 classroom school at Dunleath, the grade 1 in Saltcoats until my retirement 35 years later. One of my greatest joys is seeing and chatting with former students and knowing what fine young men and women they have become. (What's scary is some have hair as white as mine).

A red-headed mechanic, home for the holidays, helped me with my first Christmas concert at Crescent school. In 1971, I married him. Stace and I bought a house in Saltcoats and raised our 2 children, Shane, a travel agent in Vancouver and Shannon, a CCA in Langenburg Care Home.

My family and teaching were my life, but I managed to work in curling, coaching girl's softball, volunteer of Saltcoats Recreation Board and for 21 years, a member of the Saltcoats Housing Authority.

Very important to my "life journey" was the little Anglican Church in Saltcoats. I was raised to know that God was always with me but my faith was strengthened beyond my expectations through the people I met and their outreach to others. I lost my parents and only sister all in 1983 and my husband in 2011. It was that strong faith that got me through those difficult times and is still doing so today in these difficult times.

Since my retirement, I've helped look after my grandchildren, Timothy and Ailsa as well as gardening, scrap booking, crocheting, and lately, staying safe.

Just a friendly reminder...

As per Bylaw #01-2007, a Bylaw to Restrict the depositing of snow on Street of Right of Ways.

"Street Right-of-Way" means all or any part of a road allowance, public highway, road, road street thoroughfare, lane alley, walkway and sidewalk. No person shall deposit or cause to be deposited, ice or snow on any street right of way.

Business License Reminder

As per Bylaw #07-2010 of the Town of Saltcoats, no persons shall carry on any business within the town, unless and until he/she has procured a license to do so.

Fees for a 2021 Business License with the Town of Saltcoats -\$40.00

Business with the R.M. of Saltcoats-\$40.00

Any other business—\$60.00

Failure to comply shall constitute an offence under Bylaw #07-2010, with the first offence being a minimum \$50.00 or a maximum \$200.00 penalty.

A reminder that residents can make monthly payments on their utility and tax bills. Payments can be made by cash, cheque, or debit at the Town of Saltcoats Office. Residents who bank with Cornerstone Credit Union are able to set up automatic deposits, and the town accepts e-transfers for all utilities, taxes, licences, rentals, permits and any other payments you are making to the town. Dog & Cat License Reminder

It is mandatory for any person residing within the town who keeps, possesses or harbors any dog and/or cat, to obtain a pet license before January 31, 2021.

For the safety of all persons and animals involved, please ensure your pet has been vaccinated for rabies within the last 2 years.

Dog & Cat Licensing Fees:

Males: \$25.00, Females: \$25.00, Spayed or Neutered pet: \$10.00

Required Information for a License:

Proof of vaccination for rabies within the last 2 years.

Proof of spaying/neutering if applicable (if not already on file).

Color photo of pet (if not already on file).
